**Recommendation:**

THAT Bylaw No. 10726 - Road Closure and Removal of Highway Dedication Bylaw for Jenkins Road be adopted.

**Purpose:**

To consider Bylaw No. 17026 - Road Closure and Removal of Highway Dedication Bylaw for Jenkins Road for adoption. Council will invite any representation from the public regarding this proposed Road Closure.

**Background:**

Bylaw No. 10726 - Road Closure and Removal of Highway Dedication Bylaw for a portion of Jenkins Road received first, second and third readings by Council on Monday, August 20, 2012. A copy of the Bylaw is attached. As the following conditions of adoption will have been met, the Bylaw can now be adopted:

1. Newspaper Advertising placed on August 31 and September 7, 2012 with the September 10, 2012 adoption date;
2. Posted on a public notice board;
3. Opportunity for the public to provide input in the gallery before final adoption is considered;
4. After adoption, registration at Land Titles Office will occur.

**Road Closure and Removal of Highway Dedication Bylaw**  
**(Portion of Jenkins Road)**

**A bylaw pursuant to Section 40 of the Community Charter to authorize the City to permanently close and remove the highway dedication of a portion of Jenkins Road**

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, hereby enacts as follows:

1. That portion of highway attached as Schedule "A" comprising 313.3 m<sup>2</sup> shown in bold black as Road To Be Closed on the Reference Plan prepared by D.A. Goddard Land Surveyors, and completed on 22 day of June, 2012, is hereby stopped up and closed to traffic and the highway dedication removed.
2. The Mayor and City Clerk of the City of Kelowna are hereby authorized to execute such conveyances, titles, survey plans, forms and other documents on behalf of the said City as may be necessary for the purposes aforesaid.

Read a first, second and third time by the Municipal Council this 20<sup>th</sup> day of August, 2012.

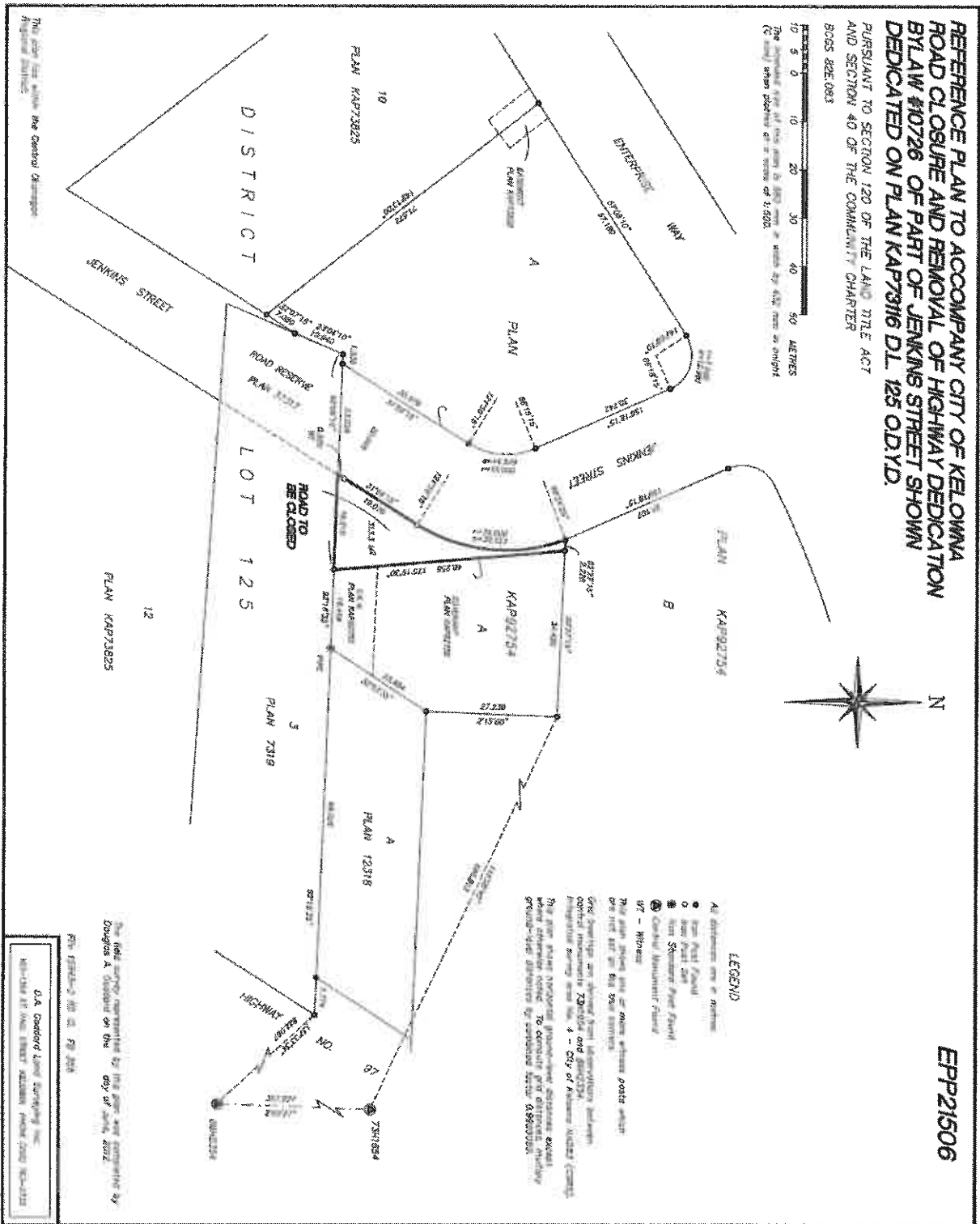
