Mayor Gray:

- Requested that the Deputy Mayor Schedule be placed on the March 18, 2013 Agenda for consideration.

3.1.1 Mayor Gray, re: PGA Canadian Tour

Mayor Gray:

- Provided an update to Council regarding the proposed PGA Canadian Tour.

Council:

- Discussed the merits and challenges of the City hosting a one-off event.
- Supportive that the tour may be coming to Kelowna.

3.1.2 Mayor Gray, re: Agricultural Land Reserve Application and the Agricultural Advisory Committee

Mayor Gray:

- Advised that he met with Rod Cook with respect to this client's ALR application that went before the Agricultural Advisory Committee in February.
- It is anticipated that the application will change prior to it coming before Council.

4. Reports

4.1. Development Process Review Project - Update

Acting General Manager, Community Sustainability:

- Provided the rationale for the Development Process Review.
- Staff has been directed to focus on the following principles:
 - Customer Service;
 - Innovative and creative approaches that are solutions-oriented when interacting with applicants;
 - Reviewing policies for duplication or redundancy;
 - Simplifying processes.

Staff:

- Provided an overview of the Development Process Review and responded to questions from Council.
- Best practices research show that the City has a number of best practices, they just need to be better supported internally.
- Believes that City-Applicant communication needs to be improved.
- Advised that recommendations will be brought forward to a future Council meeting and that it will take time to change the corporate culture.

City Manager:

- Provided comment on the Development Process.
- It was also determined that the City needs to ensure that the development community is using the online development applications tracking system.

4.2. NavCanada - British Columbia Assessment Authority Tax Assessment Ruling

Staff:

- Advised that NavCanada appealed tax assessments on four sites in British Columbia.
- The appeal decision favoured NavCanada and there are implications for the City even though Kelowna was not one of the four test properties.
- The appeal decision stated that NavCanada land and improvements should be treated as a nominal assessment for each.
- The appeal also noted that a legislative solution is required for these unique situations.
