 - 3.1. Mayor Gray, re: Issues Arising from Correspondence

3.1.1 Mayor Gray, re: Health Canada and the New Medicinal Grow-op Regulations

Mayor Gray:

 Noted that there was a one (1) hour session at the recent UBCM Convention that provided information regarding the proposed new initiative by Health Canada with respect to medicinal marijuana grow-ops.

City Clerk:

- Provided background information regarding the proposed new initiative by Health Canada.
- Provided information regarding what the City of Kelowna is proposing to coincide with the new initiative.
- Advised that a request has been made to Health Canada to obtain information on how many legal grow-ops are currently within the City of Kelowna's boundary.

Advised that a Report to Council will be forthcoming by the end of October.

- Advised that the City of Kelowna is one of four municipalities that are required to have a 'Farm Bylaw', which the City currently does not have.

Explained the challenges associated with a 'Farm Bylaw'.

- Explained the challenges with BC Assessment.

- Advised that MP Ron Cannan has been contacted and that he has agreed to assist with obtaining additional information from Health Canada.

 Clarified that Health Canada will only conduct inspections to ensure compliance with its regulations, not any of the City's regulations.

- Expressed a concern that the taxpayers of Kelowna could potentially subsidize medicinal marijuana grow-ops if they are allowed to be on agricultural lands and as agricultural lands have reduced property taxes.
