3.1. Mayor Gray, re: Issues Arising from Correspondence

# 3.1.1 Councillor Zimmermann, re: Shepherd Road Extension

Councillor Zimmermann:

- Requested an update regarding the Shepherd Road Extension.

# 4.1. Kelowna Food, Wine, Beer, and Spirits District

#### Staff:

- Advised that a Report to Council will be forthcoming with respect to the proposed Liquor Licensing changes,
- Advised that the actual boundary of the proposed "Kelowna Food, Wine, Beer, Spirits District" has not yet been defined.

#### Council:

- Confirmed that the role of Council is to promote appropriate land uses that encourage business development that may lead to competition rather than deciding where individual businesses are located.
- Expressed a concern with the present use of the area by already established 'industrial' businesses.
- Expressed a concern regarding parking in the area as industrial-zoned lands have fewer parking requirements than commercial zones.
- Expressed a concern with taxation of industrial property vs. commercial property.
