#### RECOMMENDATION:

THAT Council adopt the recommendations in the attached report from the Central Okanagan Foundation regarding agencies and amounts to be funded under the Community Social Development Grants and Grants to Address the Sexual Exploitation of Youth programs, in accordance with Council Policies 218 and 277;

AND THAT Council authorize an additional \$24,950 to be directed from Social Grants Reserve R117 for the Community Social Development Grants, in accordance with the recommendations of the Central Okanagan Foundation.

#### PURPOSE:

To authorize 2005 grant allocations under the Community Social Development and Grants to Address the Sexual Exploitation of Youth programs.

#### REPORT:

In 2004, Council approved recommendations from staff to delegate the administration of grant programs previously administered by City staff to the Central Okanagan Foundation for an administration fee of \$8,000. The grants continue to be provided in accordance with Council Policies 218 and 277, as well as 312 for Emergency Grants. In 2005, the Community Social Development grant budget was augmented to \$57,800, while the Grants to Address the Sexual Exploitation of Youth were provided with a \$22,000 budget. There is presently \$49,996 in the Social Development Grants Reserve R117. The reserve is also governed by the Council Policies and is funded by un-used portions of the annual budget allocations for the grant programs or awarded grant monies that were not paid due to an agency's inability to proceed with a program that was awarded funding. The Foundation is recommending that an additional \$24,950 be funded from the reserve to augment the 2005 Community Social Development grants budget. Emergency grants under policy 312 must also be funded from Reserve R117.

The administration of the grants programs by the COF is in the midst of a one year trial period, subject to an agreement between the City and the Foundation. Towards the end of the year, the COF and City staff will be reporting back to Council regarding the results of the one year trial period and bringing forward any recommended changes to grants procedures and annual budgets.

RE: Community Social Development Grants and Grants to Address the Sexual Exploitation of Youth for 2005

#### **Recommendation:**

That Council approves the recommendations from the Central Okanagan Foundation's ("COF") City of Kelowna Advisory Committee for grants to be allocated under the Community Social Development and Grants to Address the Sexual Exploitation of Youth programs in 2005 as set out in the tables within this report and in accordance with Council Policies 218 and 277.

#### **Report:**

The process for receiving and reviewing grants under the City's Community Social Development Grant (CSD) and Grants to Address the Sexual Exploitation of Youth (SEY) programs is now complete. This process is set out in Council Policies 218 and 277 which are provided on the City web page <u>www.city.kelowna.bc.ca</u> under Council / Policies. The procedures for each grant program are quite different but are carried out simultaneously by the COF 's City of Kelowna Advisory Committee, which includes two members of the City's Social Planning and Housing Committee. The Advisory Committee concluded its recommendations on March 17, 2005 following interviews that same day. The City's Social Planning and Housing Committee reviewed and endorsed the recommendations from the Advisory Committee, following a presentation of this information by Central Okanagan Foundation Staff. Staff also advised that in total 26 applications were received, requesting approximately \$270,000 under the CSD and SEY programs.

Council is now requested to approve the recommendations of the COF's City of Kelowna Advisory Committee regarding the grants under these two grant programs. The recommended grants are summarized in the ensuing tables according to each grant program. The procedures outlined under Council Policies 218 and 277 will continue to be followed in allocating grants and administering these programs.
