RECOMMENDATION

THAT Council receive the report from the Licence and Bylaw Enforcement Supervisor dated July 20, 2009 to amend the City of Kelowna Traffic Bylaw No. 8120;

AND THAT Bylaw No. 10217 being Amendment No. 13 to the City of Kelowna Traffic Bylaw No. 8120 be given reading consideration.

BACKGROUND

The current Traffic Regulation Bylaw No. 8120 was enacted on August 26, 2002, and included the present impound fees which were adopted from the previous Traffic bylaw No. 4495 adopted on April 25, 1978, with the last amendment fee schedule of December 3, 1996.

The City of Kelowna over the past year has updated the requirements and bring into line the standards for towing companies to conform to the rotational towing policy currently administered by the RCMP. These standards have been adopted and put in place across the board for consistent towing operations.

We are now reviewing the standard rates for vehicle impounds and storage in order to update the City of Kelowna Traffic Regulation Bylaw No. 8120, Schedule "A". We have taken into consideration the present ICBC towing and storage fee schedule amount adopted the rates to fit the needs of our City. These fees as outlined in our Bylaw have not been amended since December 3, 1996. We have also consulted with towing companies and the RCMP with all in agreement that the fees need to be raised to meet towing corporate standards.

We are recommending that the following impoundment fees, costs and expense recoveries be implemented as outlined on the attached Schedule A:

The following fees, costs and expenses shall be paid by owner of the chattel, obstruction or vehicle removed, detained or impounded:
