AND FURTHER THAT Council direct staff to bring forward Safe Premises Bylaw No.10064 at an afternoon meeting for adoption consideration.

Subject: City of Kelowna Sister City Relationships

Recommendation:

THAT Council receives for information the report dated December 4, 2013 from the Cultural Services Manager and the Grants and Partnerships Manager regarding the relationships between the City of Kelowna and its sister cities in Veendam (Netherlands), Kasugai (Japan) and Senanga (Zambia);

AND THAT Council directs staff to meet with local representatives of the Veendam and Kasugai sister city organizations to gather their input and feedback about a possible new policy direction for establishing and managing Sister City relationships;

AND THAT Council agrees to end the sister city relationship between the City of Kelowna and the District of Senanga and direct staff that no further work be done with respect to this relationship;

AND FURTHER THAT Council directs staff to provide an update report and a proposed new Sister City policy after consultations with local representatives of the current sister city organizations have been completed.

Purpose:

To provide an overview of existing Sister City policy and relationships.

Background:

The City currently has three Sister City relationships: Veendam (Netherlands), Kasugai (Japan) and Senanga (Zambia). Each relationship is unique in terms of its history, objectives and ongoing activity.

In the past, all groups have hosted visiting delegations to Kelowna and the Veendam and Kasugai groups regularly coordinate exchange visits by Kelowna delegations. The Mayor and members of Council have participated in hosting and exchange visits.

Councillors Given and Stack are appointed as liaisons to the Veendam and Kasugai groups respectively. Grants and Partnerships Manager Lorna Gunn has been a liaison with the Senanga group.

The current status of the relationships is as follows:

- 1) Veendam In June 2013 Council received a letter from the City of Veendam indicating their desire to discontinue invitations and funding support for Kelowna delegations including veterans to attend their May Liberation events after the 70th Anniversary in May 2015 due to budgetary constraints and the advancing age of the WWII veterans. In the letter an invitation was extended 'one last time' to four members of Council and/or administration as well as to two association members and two veterans. Council responded by acknowledging the history of the relationship and requesting that the invitation be forwarded again to the new Council that will be elected in 2014. Currently both the Kelowna Veendam Sister City Association (KVSCA) and the Stichting Jumelage Veendam Sister City Association are discussing their future roles after 2015.
- Kasugai The Kelowna Kasugai Sister City Association is active in the community and continues to coordinate exchange visits between Kelowna and Kasugai. A Kasugai delegation visited Kelowna in 2012, and a Kelowna delegation visited Kasugai in fall, 2013.
- 3) Zambia On February 11th, 2008 Council endorsed the Kelowna Zambia Partnership and approved a municipal sister-city relationship between the City of Kelowna and the District of Senanga, Zambia, with the scope and extent of the relationship to be determined through the research underway at that time into the city's present and future sister-city/twinning relationships and opportunities. Later that year on October 28th, a consultant's report was brought forward to Council recommending that "the City should create multi-partisan relationships between its sister cities, rather than simply bipartisan relationships, and that Kelowna should conceive of a league of four cities Kelowna, Kasugai, Senanga and Veendam - which will seek to co-operate and coordinate activities jointly in order to improve and enhance internal linkages between its members." In the months that followed and after consultation with the 3 local sister city organizations there was no desire to pursue such a recommendation. Over the past 5 years and through the volunteer efforts of city staff, ways to formalize a sister city relationship in Senanga have been explored. It is now recognized that humanitarian and political challenges present significant obstacles to creating a formal sister city relationship and staff is no longer active with respect to this relationship. Access to matching funding pursuant to Policy 355 was discontinued in 2012.

Existing Policy 355 provides for direct funding of Sister City organizations on a matching basis to cover expenses related to hosting, gift exchange and ongoing operations. Costs for travel are covered through fundraising and/or by individuals as a personal expense. The policy is specific about City funds not being used for travel expenses but is otherwise silent about objectives, outcomes and accountability for the provision of City support. Funding is accessed directly by written request with verification that the matching requirement has been met.

Requests for new Sister City relationships (or equivalents such as 'twinning') continue to come forward from the community. Staff were directed by the City Manager to develop a new policy framework within which these requests could be considered. At the same time, staff considered how a new policy might apply to existing Sister City relationships.

Staff recommend that existing Policy 355 eventually be replaced by a new policy which would govern both current and new Sister City relationships. Transition arrangements for current relationships would be included in the new policy.

Development of a new policy is informed by research conducted by the Grants and Partnerships Manager into approaches used by other jurisdictions to manage these types of relationships. Communities and organizations researched include:

- Sister City International
- City of Abbotsford
- City of Calgary
- City of Minneapolis
- City of London

A new policy approach improves:

- Alignment principles and criteria will describe why and how a Sister City relationship can be beneficial to the City of Kelowna and the community. Proposed relationships can be assessed to determine if they are aligned with the City's objectives.
- Consistency all Sister City relationships will be on the same footing, and funding arrangements for Sister City relationships will be consistent with corporate granting practices and procedures.
- Fairness the policy provides an objective, transparent process for the establishment and management of a Sister City relationship.
- Accountability Sponsor Agreements between the City of Kelowna and local sister city organizations will clarify roles and responsibilities in the Sister City relationship. Organizations provide sound justification for funding support and report back on their use of funds and the outcomes.

Pending Council Approval, staff will meet with representatives of the Veendam and Kasugai Sister City organizations to provide them with information about the proposed new policy direction, discuss the organizations' future plans, and formulate options for transition depending on the circumstances of each organization.

Financial/Budgetary Considerations:

Pursuant to Policy 355, two separate base budget allocations have been provided through Council contingency to support Sister City activities:

- a) Operating (\$2,500 annually with carryovers) used for expenses related to hosting Sister City delegations when they come to Kelowna, and to purchase gifts to be given by Kelowna delegations when they visit sister cities. The Policy specifically provides that these funds will not be used for any travel expenses; and
- b) Grant expense (\$7,500 annually) to be divided equally between the three existing Sister City organizations. These funds are to be matched by the organizations, and used to support their administrative functions and projects. Funding is accessed by written request with documentation verifying that matching requirements have been met. The Policy does not contain any provisions relating to review, reporting or accountability measures. There is no requirement to demonstrate financial need.

A new policy could provide that current Sister City organizations which wish to continue their activities will, after a one year transition period, be required to submit an application to an existing grant program to access City funding. Pending confirmation of this policy direction, staff will review what portion, if any, of the current funding should be moved from Council contingency into the appropriate grant program.

Note: The Kelowna Kasugai Sister City Association obtained a Project Grant of \$2,000 through the Cultural Services Branch in 2012. These funds supported activities of the Society relating to Asian Heritage Month.

Personnel Implications:

Currently the Grants and Partnerships Manager is the liaison with local sister city organizations and Council appointees.

Upon approval of the proposed new Sister City Policy, responsibility for the Policy and liaison will move to the Cultural Services Branch.

A. SISTER CITY PROGRAM - OPERATING

City Council has allocated ongoing base budget to be used specifically to host our Sister City delegations when they visit our community or to purchase gifts for our Sister City hosts when Council representatives visit their cities.

City Council will not use this base budget allocation for any travel expenses.

B. SISTER CITY PROGRAM – GRANT EXPENSE

City Council has allocated ongoing base budget as a matching fund for our three Sister Cities, Kasugai Sister City Association, Veendam Sister City Association and the Kelowna Zambia Partnership, to be divided equally per organization, to support their administrative functions and projects.

At any point during the year, but not later than December 31st, each organization may submit a letter of request for their portion of funding. A financial statement including that they have successfully raised 50% matching funding is required prior to City funds being released. This fundraising can also include funds raised from membership fees.

REASON FOR POLICY

To establish a policy for handling of base budgets specific to our Sister City relationships.
