

SUMMARY:

The Bylaw Notice Enforcement Bylaw designates those City Bylaws that are enforceable under the adjudication system. The Bylaw sets out the options to either pay the penalty or request dispute adjudication within a specified.

This bylaw is a 'consolidated' version and includes amendments up to the date listed in the bylaw heading. It is placed on the Internet for convenience only, is not the official or legal version, and should not be used in place of certified copies which can be obtained through the Office of the City Clerk at City Hall. ### Bylaw Notice Enforcement

---

WHEREAS the Local Government Bylaw Notice Enforcement Act Chapter 60 [SBC2003] as amended from time to time empowers the City to, by bylaw, designate those bylaws for which bylaw notice enforcement may be used as means of bylaw enforcement;

AND WHEREAS A bylaw to authorize the enforcement of bylaw notices in conjunction with Southern Interior Bylaw Notice Dispute Adjudication Registry;

NOW THEREFORE the Municipal Council of The Corporation of the City of Kelowna in open meeting assembled enacts as follows:

#### SECTION 1 - INTRODUCTION

1.1 This bylaw may be cited as "Bylaw Notice Enforcement Bylaw No.10475".

#### 1.2 Definitions

1.2.1 In this bylaw:

"Act" means the *Local Government Bylaw Notice Enforcement Act*.

"City" means The Corporation of the City of Kelowna.

"Registry" means the Southern Interior Bylaw Notice Adjudication Registry established pursuant to this Bylaw.

#### SECTION 2 - TERMS

2.1 The terms in this bylaw have the same meaning as the terms defined in the **Act**.

### SECTION 3 - BYLAW CONTRAVENTIONS

- 3.1 The bylaws and bylaw contraventions designated in Schedule "A" attached hereto and forming part of this bylaw, may be dealt with by bylaw notice.
- 3.2 The penalty for a contravention referred to in sub-section 3.1 is as follows:
- a) Subject to sub-sections 3.2(b) and 3.2(c), is the penalty amount set out in Column A1 of Schedule "A";
  - b) If received by the City within 14 days of the person receiving or being presumed to have received the notice, is the Early Payment Penalty set out in Column A2 of Schedule "A"; or
  - c) If more than 28 days after the person received or is presumed to have received the Bylaw Notice, is subject to a late payment surcharge in addition to the penalty under Subsection 3(a) and is the Late Payment Penalty set out in Column A3 of Schedule "A".

### SECTION 4 - OFFENCE AND PENALTY

- 4.1 The penalty for a contravention referred to in **SECTION 3 - BYLAW CONTRAVENTIONS** is referenced in Schedule "A".

### SECTION 5 - PERIOD FOR PAYING A DISPUTED NOTICE

- 5.1 A person who receives a bylaw notice must, within 14 days of the date on which the person received or is presumed to have received the bylaw notice:
- (a) pay the penalty, or
  - (b) request dispute adjudication,
- by filling in the appropriate portion of the bylaw notice indicating either a payment or a dispute and delivering it, either in person during regular office hours, or by mail, to the **City**.
- 5.2 A person may pay the indicated penalty after 14 days of receiving the notice, subject to the applicable surcharge for late payment accordance with Subsection 3.2(b), but no person may dispute the notice after 14 days of receiving the bylaw notice.
- 5.3 Where a person was not served personally with a bylaw notice and advises the **City**, in accordance with the requirements of Section 25 of the **Act**, that they did not receive a copy of the original notice, the time limits for responding to a bylaw notice under **SECTION 4 – OFFENCE AND PENALTY** sub-section 4.1 and **SECTION 5 - PERIOD FOR PAYING A DISPUTED NOTICE** sub-section 5.2 of this Bylaw do not begin to run until a copy of the bylaw notice is redelivered to them in accordance with the **Act**.

### SECTION 6 - BYLAW NOTICE DISPUTE ADJUDICATION REGISTRY

- 6.1 The **Registry** is established as a bylaw notice dispute adjudication system in accordance with the **Act** to resolve disputes in relation to bylaw notices.
- 6.2 The civic address of the **Registry** is the **City** of Kelowna, 1435 Water Street, Kelowna, BC, V1Y 1J4.
- 6.3 Every person who is unsuccessful in a dispute adjudication in relation to a bylaw notice or a compliance agreement under the dispute adjudication system established under this section must pay the **City** an additional fee of \$25 for the purpose of the **City** recovering the costs of the adjudication system.

## SECTION 7 - SCREENING OFFICERS

7.1 The position of screening officer is established.

BL10883 & BL11177 replaced Section 7.2:

7.2 The following are designated classes of persons that may be appointed as screening officers:

- (a) Bylaw Enforcement Clerk;
- (b) Bylaw Enforcement Coordinator;
- (c) Bylaw Services Manager;
- (d) City Clerk;
- (e) Director, Corporate Service and Protective Services;
- (f) Licence and Bylaw Enforcement Officer;
- (g) Parking Operations Coordinator;
- (h) Parking Services Manager; and
- (i) Senior Bylaw Officer.

Council may appoint Screening Officers from these classes of person by name of office or otherwise.

## SECTION 8 - POWERS, DUTIES AND FUNCTIONS OF SCREENING OFFICERS

8.1 The powers, duties and functions of screening officers are as set out in the **Act**, and include the following powers:

- (a) Where requested by the person against whom a contravention is alleged, communicate information respecting the nature of the contravention, the provision of the bylaw contravened, the facts on which the contravention allegation is based, the penalty for a contravention, the opportunity to enter into a compliance agreement, the opportunity to proceed to the bylaw notice dispute adjudication system and the fee or fees payable in relation to the bylaw notice enforcement process;
- (b) To communicate with any or all of the following for the purposes of performing their functions under this Bylaw or the **Act**:
  - (i) the person against whom a contravention is alleged or their representative;
  - (ii) the officer issuing the notice;
  - (iii) the complainant or their representative;
  - (iv) the **City's** staff and records regarding the disputant's history of bylaw compliance.
- (c) To prepare and enter into compliance agreements under the **Act** with persons who dispute bylaw notices, including to establish terms and conditions for compliance that the Screening Officer considers necessary or advisable, including time periods for payment of penalties and compliance with the Bylaw;
- (d) To provide for payment of a reduced penalty if a compliance agreement is entered into, as provided in Schedule "A"; and
- (e) To cancel bylaw notices in accordance with the **Act** or **City** policies and guidelines.

- 8.2 The bylaw contraventions in relation to which a Screening Officer may enter into a compliance agreement are indicated in Schedule "A".
- 8.3 The maximum duration of a compliance agreement is one year.

## **SECTION 9 - BYLAW ENFORCEMENT OFFICERS**

### **BL10883 amended Section 9.1:**

- 9.1 Persons acting as any of the following are designated as Bylaw Enforcement Officers for the purposes of this bylaw and the **Act**:
- (a) Special constables, officers, members or constables of:
    - (i) The provincial police force as defined in Section 1 of the *Police Act*, or
    - (ii) A municipal police force; or
    - (iii) The Royal Canadian Mounted Police Force.
  - (b) Bylaw Enforcement Officers appointed pursuant to the *Police Act* and *Community Charter*;
  - (c) Local Assistants to the Fire Commissioner under Section 6 of the *Fire Services Act*;
  - (d) Bylaw Enforcement Officers, licensing inspectors, building inspectors, animal control officers or other persons acting in another capacity on behalf of a **City** for the purpose of enforcement of one or more of its Bylaws.

## **SECTION 10 - FORM OF BYLAW NOTICE**

- 10.1 The **City** may from time to time provide for the form or forms of the bylaw notice, provided the bylaw notice complies with Section 4 of the **Act**.

## **SECTION 11 - SEVERABILITY**

- 11.1 If a portion of this Bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion must be severed and the remainder of this bylaw is deemed to have been adopted without the severed section, subsection, paragraph, subparagraph, clause or phrase.

**SECTION 12 – EFFECTIVE DATE**

12.1 This bylaw comes into force and takes effect on the date of adoption.

Read a first, second and third time by the Municipal Council this 24<sup>th</sup> day of January, 2011.
