

SUMMARY:

The Ticket Information Utilization Bylaw designates those City Bylaws which may be enforced under the municipal ticket information ("MTI") system. The Bylaw sets the fines for the offenses and designates the officials entitled to enforce each of the bylaws under the MTI system. Some of the bylaws included in the MTI system are: Building Bylaw No. 7245, Business Licence and Regulation Bylaw No. 7878, Fire Prevention Regulation Bylaw No. 6110, Traffic Bylaw No. 8120, Parks and Public Spaces Bylaw No. 6819, Zoning Bylaw No. 8000, Sign Bylaw No. 8235 and Solid Waste Management Bylaw No. 10106. For a complete list of all the bylaws covered by the MTI system, please see Schedule 1 of this bylaw.

This bylaw is a 'consolidated' version and includes amendments up to the date listed in the bylaw heading. It is placed on the Internet for convenience only, is not the official or legal version, and should not be used in place of certified copies which can be obtained through the Office of the City Clerk at City Hall. TICKET INFORMATION UTILIZATION

WHEREAS Section 272(1)(a) of the Local Government Act empowers the City to, by bylaw, designate those bylaws for which municipal ticket information may be used as means of bylaw enforcement;

AND WHEREAS Section 272(1)(c) of the Local Government Act empowers the Council to, by bylaw, authorize the use of any word or expression on a municipal ticket information to designate an offence against a bylaw;

AND WHEREAS Section 272(5) of the Local Government Act empowers the Council to, by bylaw, set fine amounts in consultation with the Chief Judge of the Provincial Court;

AND WHEREAS the Council deems it expedient to authorize the use of municipal ticket information for the enforcement of certain bylaws, to authorize the use of certain words or expressions to designate certain bylaw offences and to set certain fine amounts.

NOW THEREFORE, the Council of the City of Kelowna in open meeting assembled enacts as follows:

1. The bylaws listed in Column 1 of Schedule 1 to this bylaw, as amended from time to time, may be enforced by means of a ticket in the form prescribed for the purpose of Section 272(1)(a) of the Local Government Act.
 2. The persons appointed to the job positions or titles listed in Column 2 of Schedule 1 to this bylaw are designated as bylaw enforcement officers pursuant to Section 272(1)(b) of the Local Government Act for the purpose of enforcing the bylaws listed in Column 1 of Schedule 1 opposite the respective job positions.
- BL9638, 10381 and 10433 amended section 3:
3. The words or expressions set forth in Column 1 of Schedules 2 through 29 to this bylaw designate the offence committed under the bylaw section number appearing in Column 2 opposite the respective words or expressions.

BL9638, 10381 and 10433 amended section 4:

4. The amounts appearing in Column 3 of Schedules 2 through 29 of this bylaw are the fines set pursuant to sections 264 and 265 of the Community Charter for the corresponding offences designated in Column 1.
5. This bylaw may be cited as "City of Kelowna Ticket Information Utilization Bylaw No. 6550-89".
6. This bylaw shall take effect upon the date of its adoption.
